ABSTRACT

ELECTIONS – Ordinary Elections to Urban Local Bodies – October 2011 – Kancheepuram District – Contested candidates – Failed to lodge accounts of election expenses - Show cause notices issued – Failed to submit explanation and accounts – Disqualification – Ordered.

ORDER:

WHEREAS, in the Notification issued with the S.O. first and second read above, this Commission directed that all the contesting candidates in the elections listed therein shall lodge a true copy of their accounts of election expenses kept by them or by their respective election agent under sub-rule (1) of rule 116 of the Tamil Nadu Town panchayats, Third Grade Municipalities, Municipalities and Corporations (Elections) Rules, 2006, in the format prescribed therefor under sub-rule (2) & (3) of rule 116 of the said Rules with the officers mentioned therein, within thirty days from the date of declaration of the result of the elections;

2. WHEREAS, this Commission conducted ordinary elections to the urban local bodies during October 2011 as notified in the S.O. third read above;

3. WHEREAS, the District Election Officer/District Collector, Kancheepuram District, in his letter fourth read above reported that 302 candidates contested in the said ordinary elections for various offices failed to lodge copies of their account of election expenses as directed by this Commission;

4. WHEREAS, based on the report of the said District Election Officer/District Collector, Kancheepuram, a show cause notice was issued in the reference fifth read above to each of the contested candidate, who failed to lodge a true copy of the account of election expenses in the ordinary election held during the month of October 2011, through the District Election Officer/District Collector, calling for explanation within 21 days of the receipt of the said notice, as to why action should not be taken against him as per sub-section (2-A) of section 49 of the Tamil Nadu District Municipalities Act, 1920 (Tamil Nadu Act V of 1920);

5. WHEREAS, the said District Election Officer/District Collector, Kancheepuram in his letters sixth read above, has now reported that out of the said 302 contested candidates, two contested candidates Thiru K.Raju, Ward No. 5, Mamallapuram Town Panchayat and Thiru.Sendamarai, Ward No.11, Sriperumpudur Town Panchayat expired, 190 contested candidates, lodged the account of election expenses and the remaining 110 contested candidates have neither submitted their explanations nor lodged the account of election expenses inspite of the show cause notices issued to them;

6. WHEREAS, on receipt of show cause notice 14 candidates have submitted their accounts directly to the State Election Commission;

7. WHEREAS, in view of the said report of the District Election Officer/District Collector and of above facts, Tamil Nadu State Election Commission is satisfied that 110 candidates listed in column (3) of the Table below against the contested election mentioned in the corresponding entry in column (2) thereof, have failed to lodge their account of election expenses as required by or under the said Act and have no good reason or justification for the failure.

8. NOW ,THEREFORE, in exercise of the powers conferred by sub-section (2-A) of section 49 of the Tamil Nadu District Municipalities Act, 1920 (Tamil Nadu Act V of 1920), the Tamil Nadu State Election Commission hereby declares that the candidates listed in column (3) of the Table below against the contested election mentioned in the corresponding entry in column (2) thereof, shall be disqualified, for being elected as and for being a Chairman or a Councillor or a ward member, as the case may be, for a period of three years from the date of this Order.
