#### **ORDER:**

WHEREAS, in the Notification issued with the Statutory Order first read above, by invoking sub-rule (3) of the rule 116 of the Tamil Nadu Town Panchayats, Third Grade Municipalities, Municipalities and Corporations (Elections) Rules, 2006, the Commission directed that all the contesting candidates in the elections listed therein shall lodge a true copy of their accounts of election expenses kept by them or by their respective election agent under sub-rule (1) of rule 116 of the said Rules with the officers mentioned therein, within thirty days from the date of declaration of the result of the elections:

- 2. WHEREAS, in the Notification issued with the Statutory Order second read above, this Commission prescribed a format for the said purpose by invoking sub-rule (2) of the rule 116 of the said Rules:
- 3. WHEREAS, this Commission conducted ordinary elections to the urban local bodies during October 2011 as notified in the Statutory Order third read above;
- 4. WHEREAS, the District Election Officer/District Collector, Thoothukudi District, in his letter fourth read above reported that 238 candidates contested in the said Ordinary Elections for various offices failed to lodge copies of their account of election expenses as directed by this Commission;
- 5. WHEREAS, based on the report of the said District Election Officer/District Collector, Thoothukudi, a show cause notice was issued in the reference fifth read above to each of the 238 contested candidate, who failed to lodge a true copy of the account of election expenses in the Ordinary Elections held during the month of October 2011, through the District Election Officer/District Collector, calling for explanation within 21 days of the receipt of the said notice, as to why action should not be taken against him as per sub-section (6) of section 58 of the Coimbatore City Municipal Corporation Act, 1981 (Tamil Nadu Act 25 of 1981) read with section 8 of the Thoothukudi City Municipal Corporation Act, 2008 (Tamil Nadu Act 27 of 2008) and sub-section (2-A) of section 49 of the Tamil Nadu District Municipalities Act, 1920 (Tamil Nadu Act V of 1920), as the case may be;
- 6. WHEREAS, on receipt of show cause notices 4 number of candidates have submitted their accounts directly to the Commission and the same have been forwarded to the District Election Officer in the reference sixth cited and informed to send his remarks along with the reports of other candidates;
- 7. WHEREAS, the said District Election Officer/District Collector, in his letters seventh read above, has now reported that out of the said 238 contested candidates, two contested candidate expired, 105 contested candidates lodged their accounts of election expenses along with explanation within the time prescribed and the remaining 131 contested candidates have neither submitted their explanations nor lodged the account of election expenses inspite of the show cause notices issued to them; and
- 8. WHEREAS, in view of the said report of the District Election Officer/District Collector, Tamil Nadu State Election Commission is satisfied that 131 candidates listed in column (3) of the Table below against the contested election mentioned in the corresponding entry in column (2) thereof, have failed to lodge their account of election expenses as required by or under the said Act and have no good reason or justification for the failure;
- 9. NOW, THEREFORE, in exercise of the powers conferred by sub-section (6) of section 58 of the Coimbatore City Municipal Corporation Act, 1981 (Tamil Nadu Act 25 of 1981) read with section 8 of the Thoothukudi City Municipal Corporation Act, 2008 (Tamil Nadu Act 27 of 2008) and sub-section (2-A) of section 49 of the Tamil Nadu District Municipalities Act, 1920 (Tamil Nadu Act V of 1920), the Tamil Nadu State Election Commission hereby declares that the candidates listed in column (3) of the Table below against the contested election mentioned in the corresponding entry in column (2) thereof, shall be disqualified, for being elected as a Mayor or a Chairman or a Councillor or a ward member for a period of three years from the date of this Order.
